ANNEXURE -A- TERMS AND CONDITIONS OF THE WORK ORDER:

SCOPE OF WORK-

- 1. To appoint the certified surveyor or agency for site visit and verification of WTG location and obtain elevation certificate and survey report from certified surveyor or agency, as per prescribed format by AAI and MOD.
- 2. To prepare application and all documents required for the NOC of AAI and MOD or any other concerned department for proposed Project
- 3. To apply and submit in prescribed format with all relevant documents for NOC from AAI & MOD at designated no objection certificate application system ("NOCAS") and MOD portal respectively and get acknowledgement of application submitted.
- 4. To respond all queries as may be raised by AAI and MOD in connection with the permission including preparation of additional documents, surveys, or any other requirements for the purpose of securing NOC and on satisfactory of them and communicate with them on behalf of Company and facilitate process of the application.
- 5. To arrange all the necessary facilities for site visits like transportation, accommodation for the representative of AAI, MOD, surveyor and certification agency or any other government departments for verification of site and technical feasibility required for getting the AAI and MOD NOC.

WORK COMPLETION PERIOD –

- 1. The AAI NOC should be submitted by the Service Provider within 1 (one) month from the date of receipt of the locations details.
 - ✓ Arrange the elevation certificate and application on the portal within a week.
 - ✓ Arranging NOC with in a 3 week after submission on NOCAS Portal.
- 2. And the MOD NOC should be submitted by the Service Provider within 4 (four) months from the date of receipt of the locations details.
 - ✓ Arrange the elevation certificate, MAP, Related documents and application on the portal within
 - ✓ Arranging NOC with in a 3 Month after submission on NOCAS Portal.

TERMS OF PAYMENT

- 1. The Company shall pay 30% (thirty percent) of the WO Price, as advance upon acceptance of this WO and submission of invoice.
