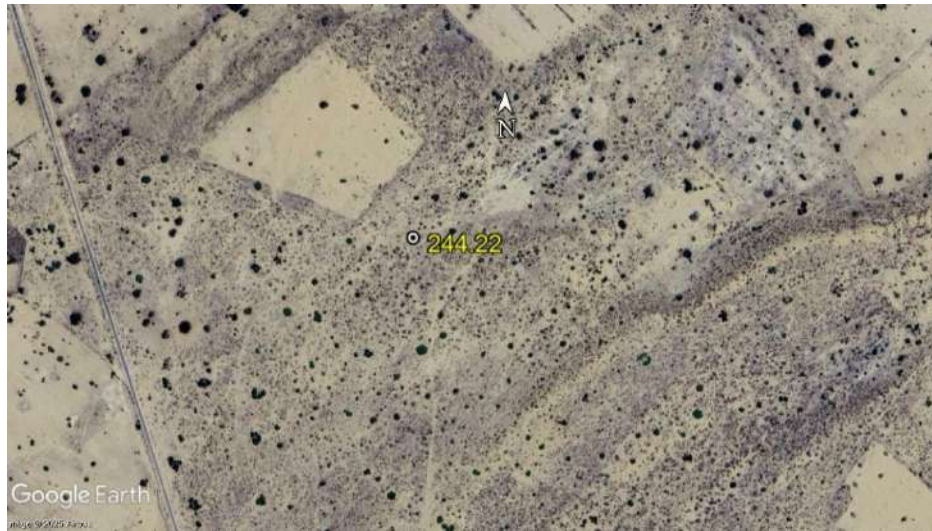

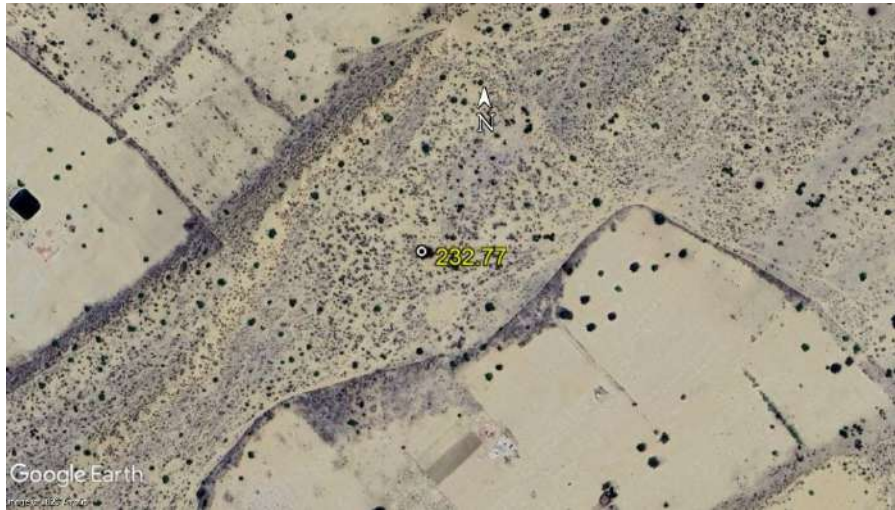

2. The site elevation and site coordinates data are correct to best of my knowledge and belief and are within permissible limits of accuracy of 50cm in vertical and 03 meters in lateral.
3. I have used the following equipment for Survey.
 - a) DGPS conforming to accuracy levels defined in 2 above along with validity of calibration certificate.
 - b) Total Station conforming to accuracy levels defined in 2 above along with validity of calibration certificate.

D. Undertaking:
